Mission, Rationale, and Strategy

MISSION

Create a leading co-invest capital provider to the North American lower middle-market (LMM) with a focus on primary and secondary transactions with independent sponsors and committed fund GPs

RATIONALE

GCI believes that the **independent sponsor market is growing at a significant pace**, providing investors exposure to less efficient parts of the market

The GCI team's direct deal expertise and Graham's network provide a strong competitive advantage

GCI expects to be viewed as a **partner of choice** due to its family office heritage, operational value-add, and deal sourcing capabilities

STRATEGY

Multipronged approach to investing in lower middlemarket companies

GCI targets investing in high-quality companies with a preference for capital efficient businesses with strong growth prospects (10%+ revenue growth) and attractive (and/or potentially improved) profit margins Initial target investment size of ~\$5MM-\$30MM
